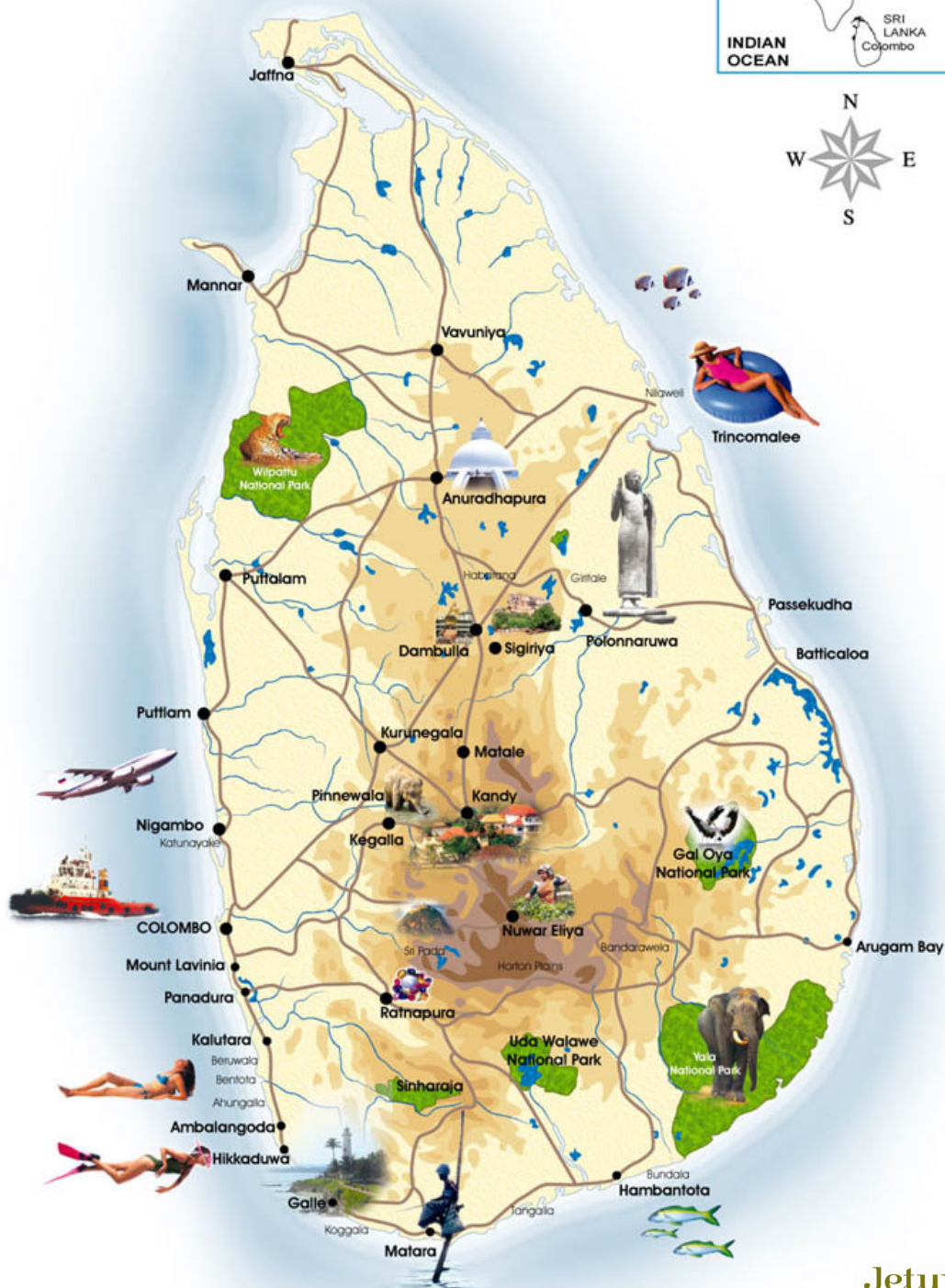

VISA REQUIREMENTS

Electronic Travel Authorization (ETA) is an official authorization for a Short Visit to Sri Lanka and is issued electronically. ETA holders will be issued a 30 day Short Visit visa at the port of entry in Sri Lanka. The ETA became effective from 1st of January 2012. An intended traveler planning a holiday visit, a short business trip or to transit through, needs to apply and obtain an ETA prior to arrival in Sri Lanka. Applications can be submitted online by visiting <http://www.eta.gov.lk> No passport copies, documents or photographs are required. There is no requirement to endorse the ETA on the passport. Upon arrival, produce your passport to the immigration officer at the port of entry to obtain the necessary clearance. It is advisable for you to bring a copy of the ETA approval notice along with you to be produced at the port of entry in Sri Lanka. All ETA holders should fulfill the following requirements at the port of entry; A passport valid for not less than 6 months from the date of arrival, a confirmed return ticket, sufficient funds to meet the expenses during the stay.

Steps to be followed:

- Click on the Apply button and fill in the ETA application.
- Pay the relevant ETA processing fee (to find out the fees applicable visit http://www.eta.gov.lk/slvisa/visainfo/fees.jsp?locale=en_US) using your electronic payment cards (credit card/e-commerce enabled debit cards) and submit the application. Only Visa, Master and American Express Cards are accepted. If you are unable to pay by electronic payment cards (credit card/e-commerce enabled debit cards), you have to select one of the alternative options.
- If your application is successfully submitted, you will receive an acknowledgment promptly
- To check your ETA application status you may log onto the ETA website or contact 24/7 dedicated ETA call centre on 0094 71 99 67 888
- Once an application is submitted processed and payment is made, you cannot cancel the transaction and the payment cannot be reimbursed. Therefore, please ensure that you enter your personal details correctly.
- Please note that for Diplomatic and Official Passport holders intending to visit Sri Lanka for Diplomatic or Official purposes should forward their ETA applications to the Department of Immigration & Emigration through relevant Sri Lanka Government Ministries and Agencies or Sri Lanka Overseas Missions
- Gratis (Free of Charge) basis is applicable only for Diplomatic and Official passport holders who come to Sri Lanka for an official visit in their official capacity.
- Nationals exempt from ETA: Nationals of the following countries who visit Sri Lanka for a Short Visit up to 30 days are exempt from ETA - The Republic of Singapore and The Republic of Maldives.
- All participants are also advised to obtain, where necessary, a transit visa for places en route to Sri Lanka before the commencement of their journey.

WHAT TO WEAR

Most travelers tend to bring too many clothes in general, and too many thick clothes in particular. In the heat and humidity of the lowlands, cotton and light natural fabrics such as linen are ideal for women during the day. However, remember that Sri Lanka is a conservative culture, so skimpy skirts and brief shorts are not considered respectable. During the evening it is advisable to wear lightweight long sleeved tops and trousers to provide some protection against mosquitoes. Women should pack a long dress or skirt and long-sleeved blouse for visiting places of worship.
